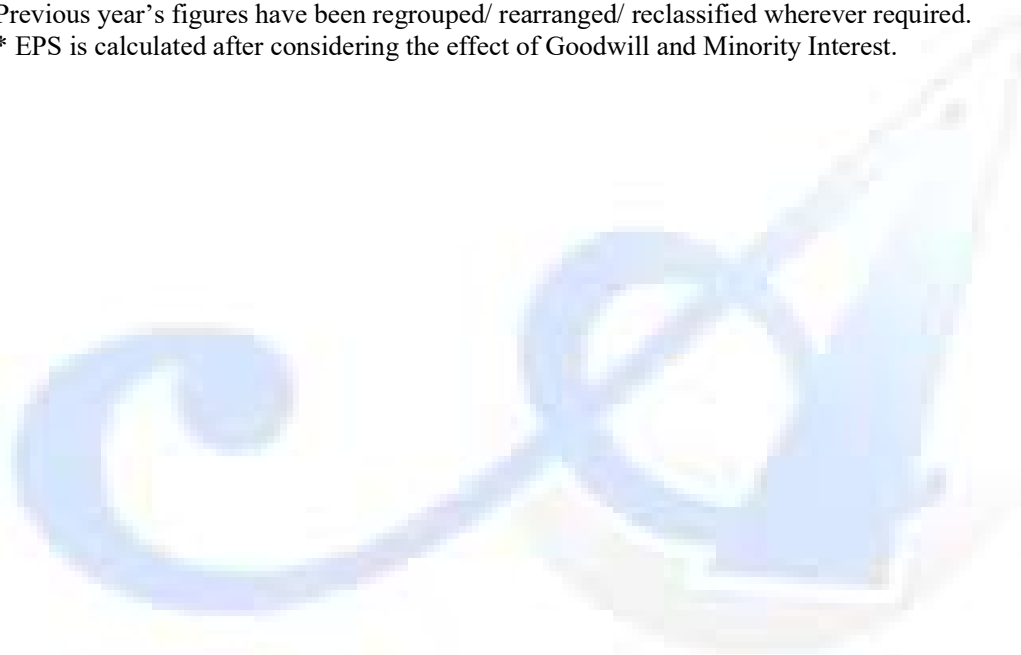


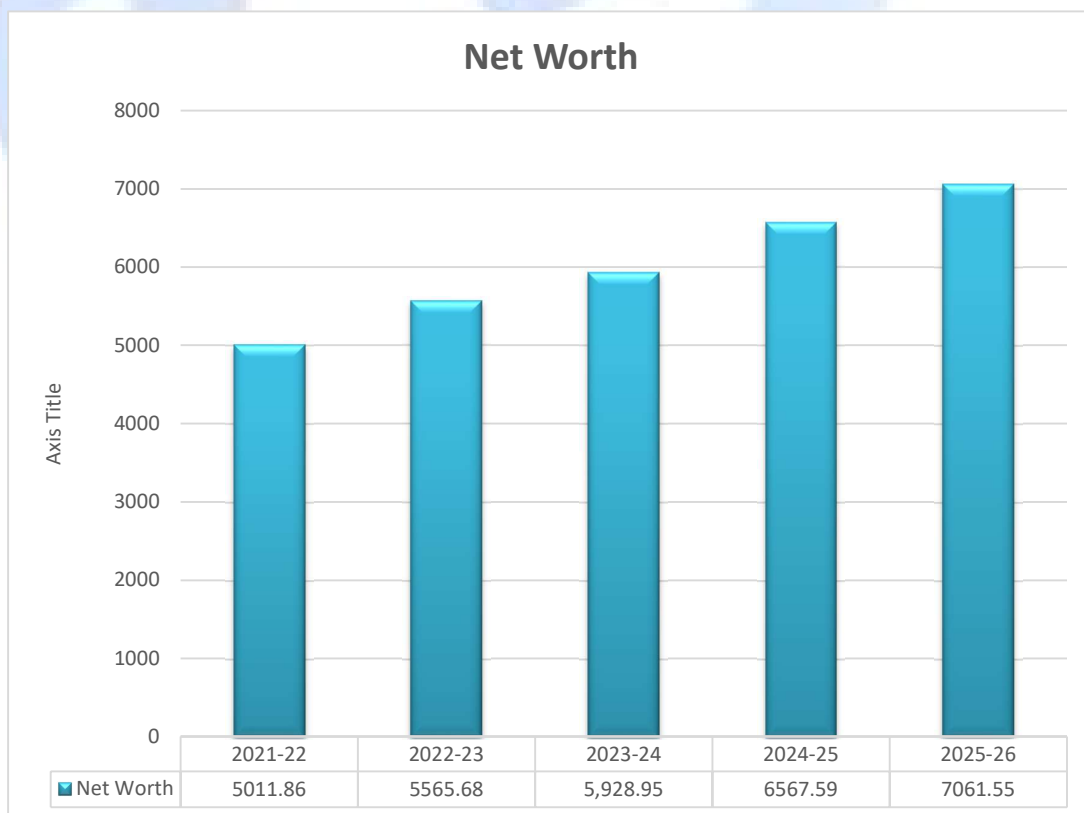
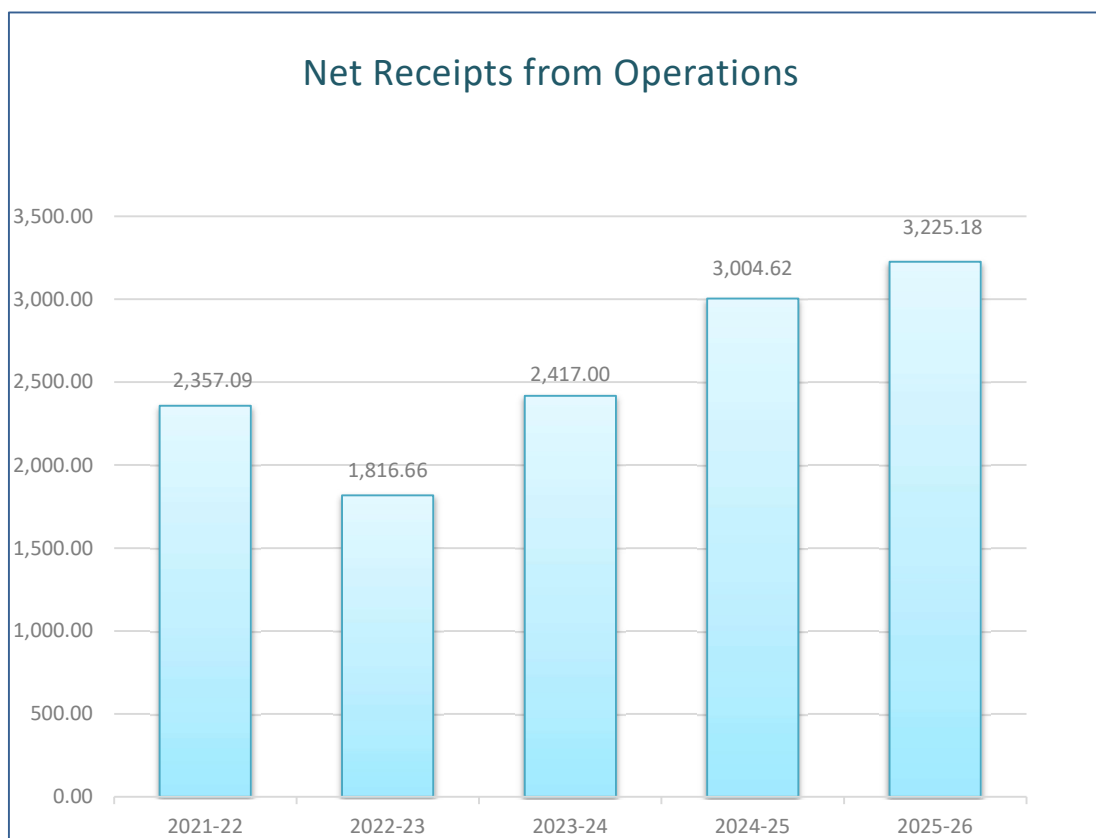

1. **A MEMBER ENTITLED TO ATTEND AND VOTE AT THE MEETING IS ENTITLED TO APPOINT ONE OR MORE PROXIES TO ATTEND AND VOTE, IN CASE OF POLL ONLY, ON HIS/HER BEHALF AND THE PROXY NEED NOT BE A MEMBER OF THE COMPANY. THE PROXY FORMS IN ORDER TO BE VALID, SHOULD BE DULY COMPLETED, STAMPED AND SIGNED AND MUST BE LODGED AT THE REGISTERED OFFICE OF THE COMPANY NOT LATER THAN 48 HOURS BEFORE THE COMMENCEMENT OF THE MEETING.** Further, a person can act as proxy on behalf of member or members not exceeding fifty and holding in the aggregate not more than ten percent of the total share capital of the company carrying voting rights provided that a member holding more than ten percent of the total share capital of the company carrying voting rights may appoint a single person as proxy and such person shall not act as proxy for any other shareholder.
2. The Statement pursuant to Section 102 of the Companies Act, 2013 in respect of the special business is annexed hereto and forms part of this Notice. In respect of required Resolutions, a statement giving additional information is annexed hereto as required under SEBI Listing Regulations, as amended, read with Secretarial Standard – 2 on General Meetings.
3. Pursuant to the provisions of Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014 (as amended) and Regulation 44 of SEBI (Listing Obligations & Disclosure Requirements) Regulations 2015 (as amended), the Company is providing facility of remote e-voting to its Members in respect of the business to be transacted at the AGM. The Company has engaged services of CDSL for facilitating remote e-voting. The facility for voting through polling paper shall also be made available at the venue of the AGM.
4. The members who have already cast their vote through remote e-voting may attend the meeting but shall not be entitled to cast their vote again at the AGM.
5. The Company has appointed CS Jigar Gorsia, Practicing Company Secretaries, Nagpur as the scrutinizer for conducting the process of e-voting and voting at the AGM in a fair and transparent manner.
6. Corporate members are requested to send their duly certified copy of the Board Resolution pursuant to Section 113 of the Companies Act, 2013 (“the Act”) authorizing their representative to attend and vote at the Annual General Meeting (including through remote e-voting) or any adjournment thereof.
7. Pursuant to the provisions of Section 91 of the Companies Act, 2013, Register of Members and the Share Transfer Books of the Company will remain closed from Friday, 18<sup>th</sup> September, 2026 to Thursday, 24<sup>th</sup> September, 2026 (both days inclusive).
8. In terms of SEBI Circular No. SEBI/HO/MIRSD/DOP1/CIR/P/2018/73 dated 20<sup>th</sup> April, 2018 read with SEBI press release PR No.: 51/2018 dated 3<sup>rd</sup> December, 2018, effective from 1<sup>st</sup> April, 2019, Company's shares can be transferred in dematerialized form only. Hence members, who hold shares in physical form, are requested to dematerialize their shares, so they can transfer their shares in future, if so desire.
9. The Register of Directors and Key Managerial Personnel and their Shareholdings, maintained under Section 170 and Register of Contracts or Arrangements in which Directors are interested maintained under Section 189 of the Companies Act, 2013 will be open for inspection for the members during the AGM.



10. Members holding shares in physical form are requested to notify immediately of any change in their address or bank mandates to the Company / Registrar and Share Transfer Agent (RTA) quoting their Folio Number and Bank Account details along with self-attested documentary proofs. Members holding shares in the electronic form may update such details with their respective Depository Participants (DP).
11. Members holding shares in identical order of names in one or more folio are requested to write to the Company's RTA, viz. M/s. MUFG Intime India Private Limited, enclosing their share certificate(s) to enable the Company to consolidate their holding into one folio for better services.
12. SEBI has mandated the submission of Permanent Account Number (PAN) by every participant in the securities market. Members holding shares in electronic form are therefore requested to submit their respective PAN details to their respective Depository Participants with whom they have their DEMAT account(s). Members holding shares in physical form can submit their PAN details to the RTA of the Company- M/s. MUFG Intime India Private Limited.
13. Non-Resident Indian members are requested to inform the Company's RTA of any change in their residential status on return to India for permanent settlement, their bank account maintained in India with complete name, branch, account type, account number and address of the bank with pin code, IFSC and MICR Code, as applicable if such details were not furnished earlier.
14. Pursuant to the provisions of Section 124(6) of the Companies Act, 2013 read with the Investor Education and Protection Fund (Accounting, Audit, Transfer and Refund) Rules, 2016, as amended, the Company has to transfer all shares in respect of which dividend has remained unpaid or unclaimed for 7 (seven) consecutive years or more to IEPF Authority.

## **20. Voting through electronic means**

In compliance with the provisions of Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014 as amended from time to time, Regulation 44 of Listing Regulations and SS-2 issued by the ICSI, the Company is pleased to provide e-voting facility to its members to cast their votes electronically on the resolutions mentioned in the Notice of the 38<sup>th</sup> AGM of the Company dated Saturday, 29<sup>th</sup> August, 2026. The Company has engaged services of Central Depository Services (India) Limited (CDSL) to provide the e-voting facility.

The facility for voting through polling paper shall also be made available at the venue of the 38<sup>th</sup> AGM. The members attending the meeting, who have not already cast their vote through e-voting shall be able to exercise their voting rights at the meeting. The members who have already cast their vote through e-voting may attend the meeting but shall not be entitled to cast their vote again at the AGM.

The Company has appointed CS Jigar Gorsia, Practicing Company Secretary, Nagpur as the scrutinizer for conducting the process of e-voting and voting through poll papers at the AGM in a fair and transparent manner.

### **THE INTRUCTIONS OF SHAREHOLDERS FOR REMOTE E-VOTING:**

- Step 1** : Access through Depositories CDSL/NSDL e-Voting system in case of individual shareholders holding shares in demat mode.
- Step 2** : Access through CDSL e-Voting system in case of shareholders holding shares in physical mode and non-individual shareholders in demat mode.
- (i) The voting period begins on Monday, 21<sup>st</sup> September, 2026(09.00 A.M.) and ends on Wednesday 23<sup>rd</sup> September, 2026 (5.00 P.M.). During this period shareholder's of the Company, holding shares either in physical form or in dematerialized form, as on the cut-off date Thursday, 18<sup>th</sup> September, 2026 may cast their vote electronically. The e-voting module shall be disabled by CDSL for voting thereafter.
  - (ii) Shareholders who have already voted prior to the meeting date would not be entitled to vote at the meeting venue.

- (iii) Pursuant to SEBI Circular No. **SEBI/HO/CFD/CMD/CIR/P/2020/242 dated 09.12.2020**, under Regulation 44 of Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, listed entities are required to provide remote e-voting facility to its shareholders, in respect of all shareholders' resolutions. However, it has been observed that the participation by the public non-institutional shareholders/retail shareholders is at a negligible level.

Currently, there are multiple e-voting service providers (ESPs) providing e-voting facility to listed entities in India. This necessitates registration on various ESPs and maintenance of multiple user IDs and passwords by the shareholders.

In order to increase the efficiency of the voting process, pursuant to a public consultation, it has been decided to enable e-voting to **all the demat account holders, by way of a single login credential, through their demat accounts/ websites of Depositories/ Depository Participants**. Demat account holders would be able to cast their vote without having to register again with the ESPs, thereby, not only facilitating seamless authentication but also enhancing ease and convenience of participating in e-voting process.

**Step 1 : Access through Depositories CDSL/NSDL e-Voting system in case of individual shareholders holding shares in demat mode.**

- (iv) In terms of **SEBI circular no. SEBI/HO/CFD/CMD/CIR/P/2020/242 dated December 9, 2020** on e-Voting facility provided by Listed Companies, Individual shareholders holding securities in demat mode are allowed to vote through their demat account maintained with Depositories and Depository Participants. Shareholders are advised to update their mobile number and email Id in their demat accounts in order to access e-Voting facility.

I am pleased to present the 38<sup>th</sup> Annual Report of our Company at the conclusion of the fiscal year 2025–26. It is both an honor and a privilege to share with you the performance highlights of the year. Looking back at the year with a sense of gratification as well as to outline our strategic roadmap for the Financial Year 2026–27. I am very happy to share the progress and prospects with you.

### **Some of the key highlights of the year include:**

Artefact Projects Limited continued to make steady progress during FY 2025–26, with total income increasing to Rs. 3,614.04 lakhs from Rs. 3,392.26 lakhs in the previous financial year. The Company recorded Profit After Tax (PAT) of Rs. 522.61 lakhs during the year as compared to Rs. 743.03 lakhs in the previous financial year. The Earnings per Share (EPS) stood at Rs. 7.29 as on March 31, 2026. The Company's performance was supported by its strong domain expertise, project delivery capabilities, manpower strength and continued project opportunities. The Company further consolidated its position through its ongoing focus on project management and its core infrastructure sector

Stakeholders trust and unwavering support besides consistent performance by the company has paved way to success.

- **Steady Project Execution Cycle:** The Company continued to maintain a healthy cycle of project execution during the year, The consistent cycle of winning, executing and completing projects has supported repeat business, and provides revenue sustained visibility.
- **Enter New Sectors:.** Artefact is also diversifying its core strength into new verticals, widening its market reach.

### OVERVIEW OF FINANCIAL PERFORMANCE:

During the year under review, the Company continued to maintain a strong performance, with total revenue registering an increase from ₹3392.26 lakh in the previous year to ₹3,614.04 lakh. The growth in revenue was primarily driven by the commencement of billing from newly project assignments undertaken, reflecting the Company's continued progress in expanding its project portfolio.

Accordingly, the Company reported a Profit after Tax (PAT) of ₹522.61 lakh for the year under review, as compared to ₹743.03 lakh in the previous year. There is a slight decline in Profit After Tax (PAT) mainly because of two specific factors i.e. 1) Commencement of 13 new projects which required upfront mobilization and operational expenditure before the revenue were commenced ; and 2) Write-off by exclusion from Work-in-Progress (WIP) of Bills raised and pending for more than 18 months in line with the Company's conservative accounting policy of recognizing income strictly on the basis of approved Bills and receipts rather than on accrual only. This resulted in a one-time, non-recurring charge to the P&L for the year by the way of reduction in WIP as on 31/03/2026. The Company continues to focus on strengthening its project execution capabilities, improving operational efficiencies and creating sustainable value for its stakeholders.



**Manpower Cost:** During the year, the Company's manpower costs increased by 11.37% as compared to previous year, due to expanding operations for execution of new projects. In addition a strategic revision of our salary structures increasing cost was undertaken to ensure alignment with New Labour Code, thereby enhancing our ability to attract talent and comply with law.

**Administrative, Selling & Other Expenses:** The Administrative, Selling and Other expenses during the year are 6.95% of Net Sales. Administrative and selling costs increased by 28.95% compared to the prior year mainly due to the initial expenses associated with mobilisation of a new site. These costs are expected to taper down once the full operations of projects at the new location progresses.

**Project Expenses:** Project expenses during the year stood at 13.82% of Net Sales. This has increased by 3.42% compared to previous year due to the initial expenses associated with launching a new project sites and we have prioritized higher quality benchmarks and safety standards across all projects. This focus has led to increased project costs related to advanced technologies and comprehensive safety protocols.

**Interest & Other Financial Charges:** Interest and other financial charges for the year amounted to Rs. 163.70 lacs, reflecting a decrease in cost of 2.10% compared to the previous year in line with utilization of Bank limits.

**Depreciation:** The Depreciation is calculated as per statute.

#### **DIVIDEND AND TRANSFER TO RESERVES :**

In order to meet the enhanced need for working capital, and substantial capital expenditure requirement of the Company. The Board of Directors of the Company deemed it prudent not to recommend any dividend for the financial year ended March 31, 2026.

The Company has transferred the profit earned during the Financial year 2025-2026 to the reserves.

#### **SHARE CAPITAL:**

During the year under review, the Authorized Share Capital of the Company was increased from Rs. 10,00,00,000/- (Rupees Ten Crore Only), divided into 1,00,00,000 (One Crore) Equity Shares of Rs. 10/- each, to Rs. 15,00,00,000/- (Rupees Fifteen Crore Only), divided into 1,50,00,000 (One Crore Fifty Lakhs) Equity Shares of Rs. 10/- each.

There was no change in the Issued, Subscribed and Paid-up Share Capital of the Company during the year under review. As on 31<sup>st</sup> March, 2026, the Issued, Subscribed and Paid-up Equity Share Capital of the Company stood at Rs. 7,27,50,000/- (Rupees Seven Crore Twenty-Seven Lakhs Fifty Thousand Only), divided into 72,75,000 (Seventy-Two Lakhs Seventy-Five Thousand) Equity Shares of Rs. 10/- (Rupees Ten) each.

## MANAGEMENT DISCUSSION AND ANALYSIS REPORT

This analysis report briefly describes the Company, current industry and business environment, ability of company to avail opportunities, exhibit strength, handling of threats/weaknesses, financial performance, internal controls and other related issues.

### INDUSTRY DEVELOPMENTS:

The infrastructure sector continues to remain a key driver of India's economic growth, supported by sustained public investment and the Government's focus on strengthening connectivity and infrastructure capacity. The Economic Survey 2025–26, Chapter 9, para 9.4, highlights that the Government of India's capital outlay increased by nearly 89%, from Rs. 5.92 lakh crore in FY 2021–22 to a budgeted Rs. 11.21 lakh crore in FY 2025–26. The Survey also highlights the continued focus on infrastructure development, multimodal connectivity and logistics efficiency.

**Budgetary Allocation:** The Union Budget 2026–27 further reinforces the Government's focus on infrastructure development. The Ministry of Road Transport and Highways has been allocated Rs. 3,09,875 crore, including Rs. 2,94,167 crore towards capital expenditure, while the Ministry of Railways has been provided Rs. 2,81,377 crore, including Rs. 2,77,830 crore towards capital expenditure. The allocations reflect the continued focus on expansion, modernisation and strengthening of India's road and railway infrastructure.

### BUSINESS OUTLOOK:

The Company continues to strengthen its position as a leading engineering consultancy and project management organization, providing end-to-end solutions for infrastructure development. With over three decades of experience, the Company offers comprehensive services in planning, design, engineering, project management, and supervision across highways, bridges, flyovers, urban infrastructure, buildings, railways, airports, water resources, and other key infrastructure sectors.

The Company's longstanding association with prestigious clients such as the National Highways Authority of India (NHAI), Ministry of Road Transport and Highways (MoRTH), Mumbai Metropolitan Region Development Authority (MMRDA), Airports Authority of India (AAI), and various Central and State Government departments, public sector undertakings, and other statutory authorities continues to provide a strong platform for business growth.

During the year, the Company has made efforts to enter into allied vertical of the railway sector and secured orders from railway authorities, marking a strategic expansion into a high-growth segment. Further, the Company has been empanelled as a Project Management Consultant (PMC) for the design of municipal roads, pavements, and underground utility ducts, along with quality assurance and quality control of various road and trench works in Mumbai BMC for a period of five years. These developments strengthen the Company's order book, enhance revenue visibility, and support its long-term growth and diversification strategy.

### THE INFRASTRUCTURE SECTOR – DEVELOPMENT, OPPORTUNITIES AND THREATS:

#### DEVELOPMENT AND OPPORTUNITIES:

The Union Budget 2026-27 outlines several significant measures aimed at enhancing infrastructure development across India, with direct relevance to the Company's business verticals of Highways, Railways and Urban Infrastructure.



The Union Budget 2026-27 has proposed seven new high-speed rail ‘Growth Connector’ corridors (Mumbai-Pune, Pune-Hyderabad, Hyderabad-Bengaluru, Hyderabad-Chennai, Chennai-Bengaluru, Delhi-Varanasi and Varanasi-Siliguri, a new Dedicated Freight Corridor linking Dankuni (East) to Surat (West), and twenty new National Waterways to be developed over the next five years. The sector continues to present strong growth opportunities, with the national highways network currently spanning over 1, 46,195 kilometers. For a Company engaged in highway and railway design and consultancy, these mega-corridors represent a multi-year pipeline of survey, detailed engineering, design review and project supervision assignments. Key Government initiatives that are expected to generate new business opportunities for the Company include:

- **Bharatmala Pariyojana** – Development of 34,800 km of national highways with an investment of Rs. 5.35 trillion.
- **PM Gati Shakti National Master Plan** – Integrates road, rail, port and logistics infrastructure planning across Ministries.
- **National Infrastructure Pipeline (NIP)** – Comprises over 1,800 critical road projects with private sector participation.
- **Development of Greenfield Expressways by the Ministry of Road Transport & Highways (MoRTH)** – 27 Greenfield corridors spanning 9,860 km are under development, creating opportunities for the Company.

These Government initiatives continued capital push into Railways, Roads & Highways and Urban Infrastructure and its steps to widen foreign and institutional participation in infrastructure financing, will enhance growth potential. The sustained growth in infrastructure investment, supported by a deepening pool of domestic and foreign capital, will offer huge business potential and opportunities for the Company in the years ahead.

## THREATS:

The Company operates in a relatively stable policy and governance environment, which supports its long-term business outlook. While no immediate structural risks are anticipated, external factors—including geopolitical conflicts, global trade tensions, tariffs, and economic volatility—could result in short-term fluctuations in operations and performance.

The Company has a substantial order book of ongoing projects aggregating to approximately Rs.338 crores, out of which projects aggregating to approximately Rs. 214 crores are being undertaken by the Company as the Lead Consultant, which provides revenue visibility for the foreseeable future.

Accordingly, the Company does not foresee any immediate threat to its business in the short term.

## RISKS AND CONCERNS:

The Company’s ability to foresee and manage business risks since more than 3 decades in infrastructure services already proven in spite of adverse external conditions in past. The Company’s long-term outlook is positive, in spite of short-term external factors.

Your Company continues to focus on its core strength in Highways as it has a strong domain expertise. Your Company has collaborated with number of reputed Foreign and Domestic Consultancy organizations for expansion in similar verticals in the infrastructure space, especially Railways and urban Infrastructure.

Appropriate and timely management intervention helps mitigate the risk of volatility in revenue receipts.



## **INTERNAL CONTROLS AND THEIR ADEQUACY:**

Your Company has adequate system of internal controls. Such internal controls are supplemented by Internal Financial Control Manual and Programme of internal audits. These are designed to ensure that financial and other records are reliable for preparing financial information and other reports and for maintaining regular accountability of the Company's assets. The Internal Auditors of your Company present their report on a quarterly basis to the Audit Committee of the Board.

A Management Information System covers major operating parameters and is reviewed regularly by the Board of Directors. Material deviations from planning and budgeting are reviewed on a quarterly basis by the Board for corrective actions.

## **NET WORTH:**

As on 31<sup>st</sup> March, 2026, the Net Worth of the Company stood healthy at Rs. 7061.55 Lacs as compared to Rs. 6567.59 Lacs during the previous financial year. This increase mainly due to profits for the year of the Company.

## **SECURED LOANS:**

Total Secured Long-Term Borrowing of the Company was Rs. 382.81 Lacs. Short Term Borrowing of the Company was Rs.1139.44 Lacs. (Including working capital loan and other long term Loans) (Sanctioned limits of Rs.1125 Lacs).

## **FIXED ASSETS:**

The Gross Block of fixed assets stood at Rs. 2492.45 Lacs as against Rs. 2404.94 Lacs for the previous year. The increase in Gross block of Fixed Assets is as a result of Normal Capital Expenditure on account of Project expansion and new project offices set up to cater to Enhanced orders.

## **CURRENT ASSETS: SUNDRY DEBTORS:**

Sundry Debtors stood at Rs. 1641.15 Lacs as on 31<sup>st</sup> March 2026 as against Rs. 1230.43 Lacs during the previous financial year. Debtors include GST Receivable of Rs. 463.66 Lacs. Debtors mainly comprise of project and quarter end billings and outstanding Bills due of last quarter pending approvals. All clients are Government/ PSU. Due to the formal prior approval based system of obtaining payments of the invoices, the Company has to sustain certain levels of Debtors as a normal business feature.

## **CASH & BANK BALANCES:**

The Cash and Bank Balances stood at Rs. 222.72 Lacs. This mainly includes due to fixed deposits pledged with Banks as 100% cash Collateral for Bank guarantees issued by the company to its clients as per Contractual requirement.

## **LOANS & ADVANCES:**

Current Short Term Business Loans and Advances stood at Rs. 1762.31 Lacs (Previous year Rs. 1696.40 Lacs). And Long Term Business Loans and Advances stood at Rs 3200 Lakhs (Previous year Rs. 3200.53 Lacs) in line with previous year's level.



## **CURRENT LIABILITIES & PROVISIONS (EXCLUDING CURRENT MATURITY OF SECURED LOAN):**

The current liabilities and long term provisions stood at Rs. 2611.08 Lacs (previous year Rs. 1962.71 Lacs). This mainly consists of Trade Payables, Statutory Liability and other Provisions in the books.

## **HUMAN RESOURCES AND INDUSTRIAL RELATIONS:**

The Company continues its committed priority on Human capital.

The Company has adopted Indian Accounting Standard (IND-AS), notified under the Companies (Accounting) Rules, 2015.

As at the end of the financial year 2025–2026, the Company's human resources comprised 186 Technical employees and 99 Non-Technical employees, aggregating to a total 285 workforce of employees

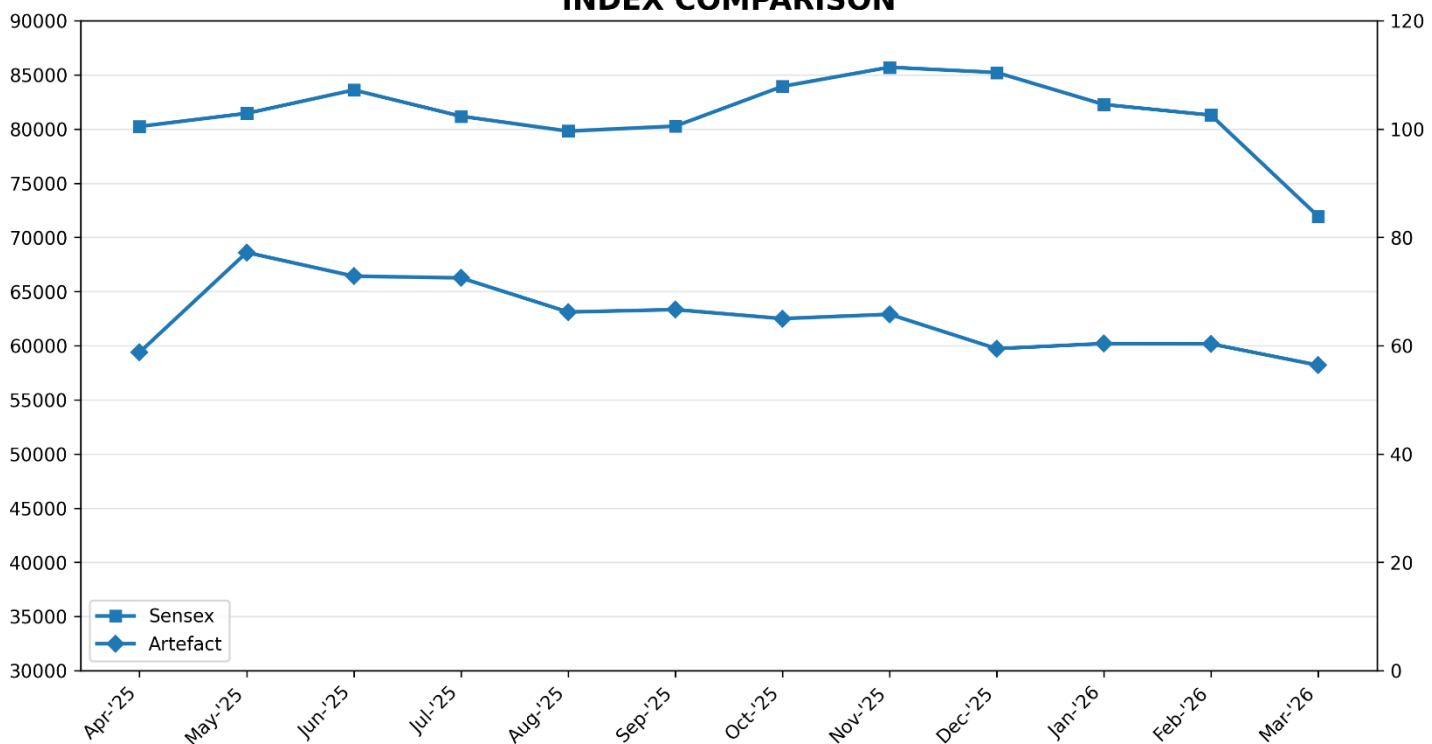

### Investor Grievance Handling Mechanism:

All share related transactions viz. transfer, transmission, transposition, nomination, dividend, change of name/address/signature, registration of mandate/ Power of Attorney, replacement/ split/ consolidation of share certificates, demat/ remat of shares, issue of duplicate certificates etc. are being handled by MUFG Intime India Private Limited, the Registrar and Share Transfer Agent. They also discharge investor service functions effectively, efficiently and expeditiously.

Investors are required to correspond directly with MUFG Intime India Private Limited, on all share related matters.

The Board of Directors of the Company has constituted a Stakeholders' Relationship Committee (the Committee) which *inter alia*, approves issue of duplicate certificates and oversees and reviews all matters connected with share transfers and other processes. The Committee also looks into the redressal of shareholders complaints related to transfer of shares, non-receipt of Dividend etc. The Committee oversees the performance of the R & T Agent and recommends measures for overall improvement in the quality of investor services.

### Recommendation by Company to Shareholders/ Investors:

In pursuit of the Company's objective to mitigate / avoid risks while dealing with shares and related matters, the following are the Company's recommendations to shareholders/ investors:

- **Adoption of Green Initiative:**

The Ministry of Corporate Affairs has taken a "Green Initiative in the Corporate Governance" by allowing paperless compliances by the companies and has issued circulars stating that service of notice/documents including Annual Report can be sent by e-mail to its members. To support this green initiative of the Government in full measure, members who have not registered their e-mail addresses, so far, are requested to register their e-mail addresses, in respect of electronic holdings with the Depository through their concerned Depository Participants.

- **Opening of DEMAT account and dematerialize your shares:**

Investors should convert their physical holdings of shares into DEMAT holdings. Holding shares in DEMAT form helps investors to get immediate transfer of the shares. No stamp duty is payable on transfer of shares held in DEMAT form and risk associated with physical certificates such as forged transfers, fake certificates and bad deliveries are avoided.



- **Register ECS mandate and furnish correct bank account particulars with the Company/ Depository Participant (DP):**

Investors should provide an ECS mandate to the Company in case of shares held in physical form and in case of shares held in DEMAT form ensure that the correct and updated particulars of his bank account are available with the Depository Participant (DP). This would facilitate direct credit of dividends, refunds etc. from companies to their bank account and avoid postal delays and loss in transit.

- **Fill and submit nomination form:**

Through SCORES the investors can view online, the action taken and current status of the complaints.

### **Course of action in case of non-receipt of Dividend, Revalidation of Dividend warrant etc.**

Shareholders may write to the Company R & T Agent, furnishing particulars of the dividend not received and quoting the folio number (in case of shares held in physical mode)/ DP ID and Client ID particulars (in case of shares held in DEMAT mode). The R & T Agent shall check the records and issue Demand Draft if the dividend remains unpaid in the records of the Company after expiry of the validity period of the warrant which is normally three months from the date of its issue. In case of loss of original dividend warrant the shareholders have to wait since demand draft cannot be issued till the expiry of the validity period of the original dividend warrant and the shareholder has to execute a letter of indemnity. On the expiry of the validity period if the dividend warrant is still shown as unpaid in the records of the Company, demand draft will be issued. However, demand drafts will not be issued against those shares wherein a 'stop transfer indicator' has been instituted either by virtue of a complaint or by law, unless the procedure for releasing the same has been completed.

**Background**

Artefact Projects Limited (hereinafter referred to as the 'Company') is a company limited by shares, incorporated and domiciled in India. The Company's equity shares are listed on the Bombay Stock Exchange in India. The registered office of the Company is situated at Regd. Office :105, 2nd Floor, "Artefact Towers", Chhatrapati Square, Wardha Road, Nagpur- 440015, Maharashtra, India. The principal place of the business of the Company is situated at 105, 2nd Floor, "Artefact Towers", Chhatrapati Square, Wardha Road, Nagpur- 440015.

The Company is primarily engaged in Project Consultancy business in India as Consulting Engineers, Architects and Planners.

**Note 1 Significant accounting policies**

This note provides a list of the significant accounting policies adopted in the preparation of these financial statements of the Company. These policies have been consistently applied to all the years presented, unless otherwise stated.

**1.01 Basis of preparation**

*i Compliance with Ind AS*

The financial statements comply in all material aspects with Indian Accounting Standards (Ind AS) notified under Section 133 of the Companies Act, 2013 (the Act) [Companies (Indian Accounting Standards) Rules, 2015 and Companies (Indian Accounting Standards) Rules, 2016] and other relevant provisions of the Act.

The financial statements up to year ended March 31, 2017 were prepared in accordance with Indian GAAP, including the accounting standards notified under Companies (Accounting Standard) Rules, 2006 (as amended) and other relevant provisions of the Act.

The financial statements for the year ended 31st March, 2018 were the first financial statements of the Company under Ind AS.

*ii Historical cost convention*

The financial statements have been prepared on a historical cost basis, except for the following:

Defined benefit plans - plan assets measured at fair value; and

*iii Current and non-current classification*

All assets and liabilities have been classified as current and non-current as per the Company's normal operating cycle (twelve months) and other criteria set out in the Schedule III to the Act.

**1.02 Foreign currency translation.**

*i Functional and presentation currency*

Items included in the financial statements of the Company are measured using the currency of the primary economic environment in which the Company operates ('the functional currency'). The financial statements are presented in Indian rupee (INR / Rs.), which is the Company's functional and presentation currency.

*ii Transaction and balances*

Foreign currency transactions, if any are translated into the functional currency using the exchange rates on the dates of the transaction. Foreign exchange gains and losses resulting from the settlement of such transactions if any and from the translation of monetary assets and liabilities denominated in foreign currencies at year end exchange rates are generally recognised in profit or loss or Other Comprehensive Income.

All foreign exchange gains and losses are presented in the statement of profit and loss on a net basis within other gains/(losses), if any

**1.03 Revenue Recognition**

Revenue is measured at the fair value of the consideration received or receivable and is Net of GST.

The Company recognises revenue when the amount of revenue accepted by client as per contract. It is probable that future economic benefits will flow to the entity.

**Revenue from services**

Project Consultancy Income is recognized in the accounting period in which the services are rendered, and accepted and approved by client. The Services Provided and for Bills submitted pending approval are considered as work in progress at cost. This includes bills of previous years pending approval and accounted for as Revenue now considered as work in progress as per the uniform accounting policy applicable therefore.

**1.04 Income tax**

The income tax expense or credit for the period is the tax payable on the current period's taxable income based on the applicable income tax rate adjusted by changes in deferred tax assets and liabilities attributable to temporary differences and to unused tax losses.

The current income tax charge is calculated on the basis of the tax laws enacted or substantively enacted at the end of reporting period in India where the Company operates and generates taxable income. Management periodically evaluates positions taken in tax returns with respect to situations in which applicable tax regulations is subject to interpretation. It establishes provisions where appropriate on the basis of amounts expected to be paid to the tax authorities.

Deferred income tax is provided in full, using the liability method, on temporary differences arising between the tax bases of assets and liabilities and their carrying amounts in the financial statements.

Deferred tax assets are recognised for all deductible temporary differences and unused tax losses only if it is probable that future taxable amounts will be available to utilise those temporary differences and losses.

Current and deferred tax is recognised in profit or loss, except to the extent that it relates to items recognised in other comprehensive income or directly in equity. In this case, the tax is also recognised in other comprehensive income or directly in equity, respectively.

#### **1.05 Impairment of assets**

Property, plant and equipment and other assets are tested for impairment whenever events or changes in circumstances indicate that the carrying amount may not be recoverable. An impairment loss is recognised for the amount by which the asset's carrying amount exceeds its recoverable amount. The recoverable amount is the higher of an asset's fair value less costs of disposal and value in use. For the purposes of assessing impairment, assets are grouped at the lowest levels for which there are separately identifiable cash inflows which are largely independent of the cash inflows from other assets or groups of assets (cash-generating units). Non-financial assets other than goodwill that suffered an impairment are reviewed for possible reversal of impairment at the end of each reporting period.

#### **1.06 Cash and cash equivalents**

For the purpose of presentation in the statement of cash flows, cash and cash equivalents includes cash on hand, deposits held at call with financial institutions, other short-term, highly liquid investments that are readily convertible to known amounts of cash and which are subject to an insignificant risk of changes in value, and bank overdrafts. Bank overdrafts are shown within borrowings in current liabilities in the balance sheet.

#### **1.07 Trade receivables**

Trade receivables are recognised initially at fair value and subsequently measured at amortised cost using the effective interest method, less provision for impairment.

#### **1.08 Investments and other financial assets**

##### ***Classification***

The Company classifies its financial assets in the following measurement categories: -those to be measured subsequently at fair value (through profit or loss), and -those measured at amortised cost.

The classification depends on the entity's business model for managing the financial assets and the contractual terms of the cash flows.

For assets measured at fair value, gains and losses will be recorded in profit or loss. For investment in debt instrument, this will depend on the business model in which the investment is held. For investments in equity instruments, this will depend on whether the Group has made an irrevocable election at the time of initial recognition to account for the equity investment at fair value through other comprehensive income.

The Company reclassifies debt investments when and only when its business model for managing those assets changes.

##### ***Measurement***

At initial recognition, the Company measures a financial asset at its fair value plus, in the case of a financial asset not at fair value through profit or loss, transaction costs that are directly attributable to the acquisition of the financial asset. Transaction costs of financial assets carried at fair value through profit or loss are expensed in statement of profit and loss.

##### ***Debt instruments***

Subsequent measurement of debt instruments depends on the Company's business model for managing the asset and the cash flow characteristics of the asset.

##### ***Equity instruments***

The Company subsequently measures all equity investments at fair value. Dividends from such investments are recognised in profit or loss as other income when the right to receive payments is established.

Changes in the fair value of financial assets at fair value through profit or loss are recognised in other gain/ (losses) in the statement of profit and loss. Impairment losses (and reversal of impairment losses) on equity investments measured at FVOCI are not reported separately from other changes in fair value.

##### ***Impairment of financial assets***

The company assesses on a forward looking basis the expected credit losses associated with its assets carried at amortised.

For trade receivables, the company applies the simplified approach permitted by Ind AS 109 Financial Instruments, which requires expected lifetime losses to be recognised from initial recognition of the receivables.

### ***Derecognition of financial assets***

A financial asset is derecognised only when: The Company has transferred the rights to receive cash flows from the financial asset or retains the contractual rights to receive the cash flows of the financial asset, but assumes a contractual obligation to pay the cash flows to one or more recipients.

Where the Company has transferred an asset, the Company evaluates whether it has transferred substantially all risks and rewards of ownership of the financial asset. In such cases, the financial asset is derecognised. Where the entity has not transferred substantially all risks and rewards of ownership of the financial asset, the financial asset is not derecognised.

Where the entity has neither transferred a financial asset nor retains substantially all risks and rewards of ownership of the financial asset, the financial asset is derecognised if the Company has not retained control of the financial asset. Where the Company retains control of the financial asset, the asset is continued to be recognised to the extent of continuing involvement in the financial asset.

## **1.09 Property, plant and equipment**

Property, plant and equipment are stated at historical cost less depreciation and impairment losses, if any. Historical cost includes expenditure that is directly attributable to the acquisition of the items.

Subsequent costs are included in the asset's carrying amount or recognised as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item will flow to the Company and the cost of the item can be measured reliably. The carrying amount of any component accounted for as a separate asset is derecognised when replaced. All other repairs and maintenance are charged to profit or loss during the reporting period in which they are incurred.

### ***Transition to Ind AS***

On transition to Ind AS, the Company has elected to continue with the carrying value of all of its property, plant and equipment recognised as at April 1, 2016 measured as per the previous GAAP and use that carrying value as the deemed cost of the property, plant and equipment.

### ***Depreciation methods on above***

Depreciation on property, plant and equipment (other than leasehold land, leasehold improvements, continuous process plant and machinery and vehicles) is calculated using the straight-line method to allocate their cost, net of their residual values, over their estimated useful lives as prescribed under Schedule II to the Companies Act, 2013, which approximate the useful lives of the assets estimated by the management.

The residual values are not more than 5% of the original cost of the asset. The asset's residual values and useful lives are reviewed, and adjusted, if appropriate, at the end of each reporting period.

An asset's carrying amount is written down immediately to its recoverable amount if the asset's carrying amount is greater than its recoverable amount.

Gains and losses on disposals are determined by comparing proceeds with carrying amount. These are included in profit or loss within other gains/(losses).

## **1.10 Intangible assets**

Acquired intangible assets are shown at historical cost. They have a finite useful life and are subsequently carried at cost less accumulated amortisation and impairment losses, if any.

### ***Amortisation methods and periods***

The Company amortises intangible assets with a finite useful life using the straight-line method over the following periods: Computer software: 3 years

### ***Transition to Ind AS***

On transition to Ind AS, the Company has elected to continue with the carrying value of all of intangible assets recognised as at April 1, 2016 measured as per the previous GAAP and use that carrying value as the deemed cost of intangible assets.

## **1.11 Trade and other payables**

These amounts represent liabilities for goods and services provided to the Company prior to the end of financial year which are unpaid. The amounts are unsecured and are usually paid within 90 days of recognition. Trade and other payables are presented as current liabilities unless payment is not due within 12 months after the reporting period. They are recognised initially at their fair value and subsequently measured at amortised cost using the effective interest method.

### 1.12 Borrowings

Borrowings are initially recognised at fair value, net of transaction costs incurred. Borrowings are subsequently measured at amortised cost. Any difference between the proceeds (net of transaction costs) and the redemption amount is recognised in profit or loss over the period of the borrowings using the effective interest method. Fees paid on the establishment of loan facilities are recognised as transaction costs of the loan to the extent that it is probable that some or all of the facility will be drawn down. In this case, the fee is deferred until the draw down occurs. To the extent there is no evidence that it is probable that some or all of the facility will be drawn down, the fee is capitalised as a prepayment for liquidity services and amortised over the period of the facility to which it relates.

Borrowings are removed from the balance sheet when the obligation specified in the contract is discharged, cancelled or expired. The difference between the carrying amount of a financial liability that has been extinguished or transferred to another party and the consideration paid, including any non-cash assets transferred or liabilities assumed, is recognised in profit or loss as other gains/(losses).

Borrowings are classified as current liabilities unless the Company has an unconditional right to defer settlement of the liability for at least 12 months after the reporting period. Where there is a breach of a material provision of a long-term loan arrangement on or before the end of the reporting period with the effect that the liability becomes payable on demand on the reporting date, the entity does not classify the liability as current, if the lender agreed, after the reporting period and before the approval of the financial statements for issue, not to demand payment as a consequence of the breach.

### 1.13 Borrowing costs

General and specific borrowing costs that are directly attributable to the acquisition, construction or production of a qualifying asset are capitalised during the period of time that is required to complete and prepare the asset for its intended use or sale. Qualifying assets are assets that necessarily take a substantial period of time to get ready for their intended use or sale.

Investment income earned on the temporary investment of specific borrowings pending their expenditure on qualifying assets is deducted from the borrowing costs eligible for capitalisation.

Other borrowing costs are expensed in the period in which they are incurred.

### 1.14 Provisions, Contingent Liabilities and Contingent Assets

Contingent Liabilities are disclosed in respect of possible obligations that arise from past events but their existence will be confirmed by the occurrence or non-occurrence of one or more uncertain future events not wholly within the control of the Company or where any present obligation cannot be measured in terms of future outflow of resources or where a reliable estimate of the obligation cannot be made.

Provisions for legal claims, service warranties, volume discounts and returns are recognised when the company has a present legal or constructive obligation as a result of past events, it is probable that an outflow of resources will be required to settle the obligation and the amount can be reliably estimated. Provisions are not recognised for future operating losses.

Where there are a number of similar obligations, the likelihood that an outflow will be required in settlement is determined by considering the class of obligations as a whole. A provision is recognised even if the likelihood of an outflow with respect to any one item included in the same class of obligations

Provisions are measured at the present value of management's best estimate of the expenditure required to settle the present obligation at the end of the reporting period. The discount rate used to determine the present value is a pre-tax rate that reflects current market assessments of the time value of money and the risks specific to the liability. The increase in the provision due to the passage of time is recognised as interest expense.

A contingent asset is disclosed and not recognised, where an inflow of economic benefits is probable.

### 1.15 Employee benefits

#### ***Short-term obligation***

Liabilities for salaries, including non-monetary benefits that are expected to be settled wholly within 12 months after the end of the period in which the employees render the related service are recognised in respect of employee's services up to the end of the reporting period and are measured at the amounts expected to be paid when the liabilities are settled. The liabilities are presented as current employee benefit obligations in the balance sheet.

#### ***Other long-term employee benefits obligations***

The liabilities for earned leave are not expected to be settled wholly within 12 months after the end of the period in which the employees render the related service. They are therefore measured as the present value of expected future payments to be made in respect of services provided by employees up to the end of the reporting period using the projected unit credit method. The benefits are discounted using the market yields at the end of the reporting period that have terms approximating to the terms of the related obligation. Remeasurements as a result of experience adjustments and changes in actuarial assumptions are recognised in profit or loss.

The obligations are presented as current liabilities in the balance sheet if the entity does not have an unconditional right to defer settlement for at least twelve months after the reporting period, regardless of when the actual settlement is expected to occur.

**Post employment obligation**

The Company operates the following post-employment schemes: defined benefit plan, i.e., gratuity, defined contribution plans such as provident fund.

**Gratuity obligations**

The liability or asset recognised in the balance sheet in respect of defined benefit gratuity plans is the present value of the defined benefit obligation at the end of the reporting period less the fair value of plan assets. The defined benefit obligation is calculated annually by actuaries using the projected unit credit method.

The present value of the defined benefit obligation denominated in INR is determined by discounting the estimated future cash outflows by reference to market yields at the end of the reporting period on government bonds that have terms approximating to the terms of the related obligation.

The net interest cost is calculated by applying the discount rate to the net balance of the defined benefit obligation and the fair value of plan assets.

This cost is included in employee benefit expense in the statement of profit and loss.

Remeasurement gains and losses arising from experience adjustments and changes in actuarial assumptions are recognised in the period in which they occur, directly in other comprehensive income. They are included in retained earnings in the statement of changes in equity and in the balance sheet.

Changes in the present value of the defined benefit obligation resulting from plan amendments or curtailments are recognised immediately in profit or loss as past service cost.

**Defined contribution plans**

The Company pays provident fund and employee state insurance contributions to government administered Employee Provident Fund Organisation and Employee State Insurance Corporation respectively. The Company has no further payment obligations once the contributions have been paid. The contributions are accounted for as defined contribution plans and the contributions are recognised as employee benefit expense when they are due. Prepaid contributions are recognised as an asset to the extent that a cash refund or a reduction in the future payments is available.

**1.16 Dividends**

Provision is made for the amount of any dividend declared, being appropriately authorised and no longer at the discretion of the entity, on or before the end of the reporting period but not distributed at the end of the reporting period.

**1.17 Earnings per share**

Basic earnings per share is calculated by dividing: the profit attributable to owners of the Company by the weighted average number of equity shares outstanding during the financial year.

Diluted earnings per share adjusts the figures used in the determination of basic earnings per share to take into account: the after income tax effect of interest and other financing costs associated with dilutive potential equity shares, and the weighted average number of additional equity shares that would have been outstanding assuming the conversion of all dilutive potential equity shares.

**1.18 Inventories**

Inventories represents the WIP in respect of Project Management Consultancy Services in progress and remained unbilled. Inventories have been valued at cost.

**1.19 Accounting for Joint Venture Operations**

The Financial Statements reflect the share of the Company's assets and liabilities as well as income and expenditure of Joint Venture.

Operations which are accounted for according to the participating interest of the company as per the various Joint Venture Agreements on a line by line basis along with similar items in the company's financial statements.

**1.20 Provision for current and deferred tax**

Provision for current and deferred tax is made after taking into consideration benefits admissible under the Provision of Income Tax Act 1961. Deferred tax resulting from timing differences "between book and taxable profit is accounted for using the tax rates and laws that have been enacted or substantively enacted as on the balance sheet date. The deferred tax asset is recognised and carried forward only to the extent that there is reasonable/virtual certainty that asset will be realized against future taxable profits.

## **Note 2**

### **Critical Accounting Judgements, Estimates and Assumptions**

The preparation of the financial statements requires management to exercise judgment and to make estimates and assumptions. These estimates and associated assumptions are based on historical experiences and various other factors that are believed to be reasonable under the circumstances. Actual results may differ from these estimates. The estimates and underlying assumptions are reviewed on an ongoing basis. Revision to accounting estimates are recognised in the period in which the estimate is revised if the revision affect only that period, or in the period of the revision and future periods if the revision affects both current and future period.

The areas involving critical estimates or judgements are as under:

**a Estimation of current tax expenses and payable:**

Taxes recognized in the financial statements reflect management's best estimate of the outcome based on the facts known at the balance sheet date. These facts include but are not limited to interpretation of tax laws of various jurisdictions where the Company operates. Any difference between the estimates and final tax assessments will impact the income tax as well the resulting assets and liabilities.

**b Estimated fair value of unlisted securities:**

The fair value of financial instruments that are not traded in an active market is determined using valuation techniques. The Company uses its judgement to select a variety of methods and make assumptions that are mainly based on the market conditions existing at the end of each reporting period.

**c Useful lives of property, plant and equipment and Intangible assets:**

Depreciation and amortization is based on management estimates of the future useful lives of the property, plant and equipment and intangible assets. Estimates may change due to technological developments, competition, changes in market conditions and other factors and may result in changes in the estimated useful life and in the depreciation and amortisation charges.

**d Estimation of defined benefit obligation:**

The liabilities of the company arising from employee benefit obligations and the related current service cost, are determined on an actuarial basis using various assumptions.

**e Impairment of financial assets (including trade receivables):**

Allowance for doubtful receivables represent the estimate of losses that could arise due to inability of the Customer to make payments when due. These estimates are based on the customer ageing, customer category, specific credit circumstances and the historical experience of the group as well as forward looking estimates at the end of each reporting period.

**f Estimation of Provisions and contingencies:**

Provisions are liabilities of uncertain amount or timing recognised where a legal or constructive obligation exists at the balance sheet date, as a result of a past event, where the amount of the obligation can be reliably estimated and where the outflow of economic benefit is probable. Contingent liabilities are possible obligations that may arise from past event whose existence will be confirmed only by the occurrence or non-occurrence of one or more uncertain future events which are not fully within the control of the Company. The Company exercises judgement and estimates in recognizing the provisions and assessing the exposure to contingent liabilities relating to pending litigations. Judgement is necessary in assessing the likelihood of the success of the pending claim and to quantify the possible range of financial settlement. Due to this inherent uncertainty in the evaluation process, actual losses may be different from originally estimated provision.

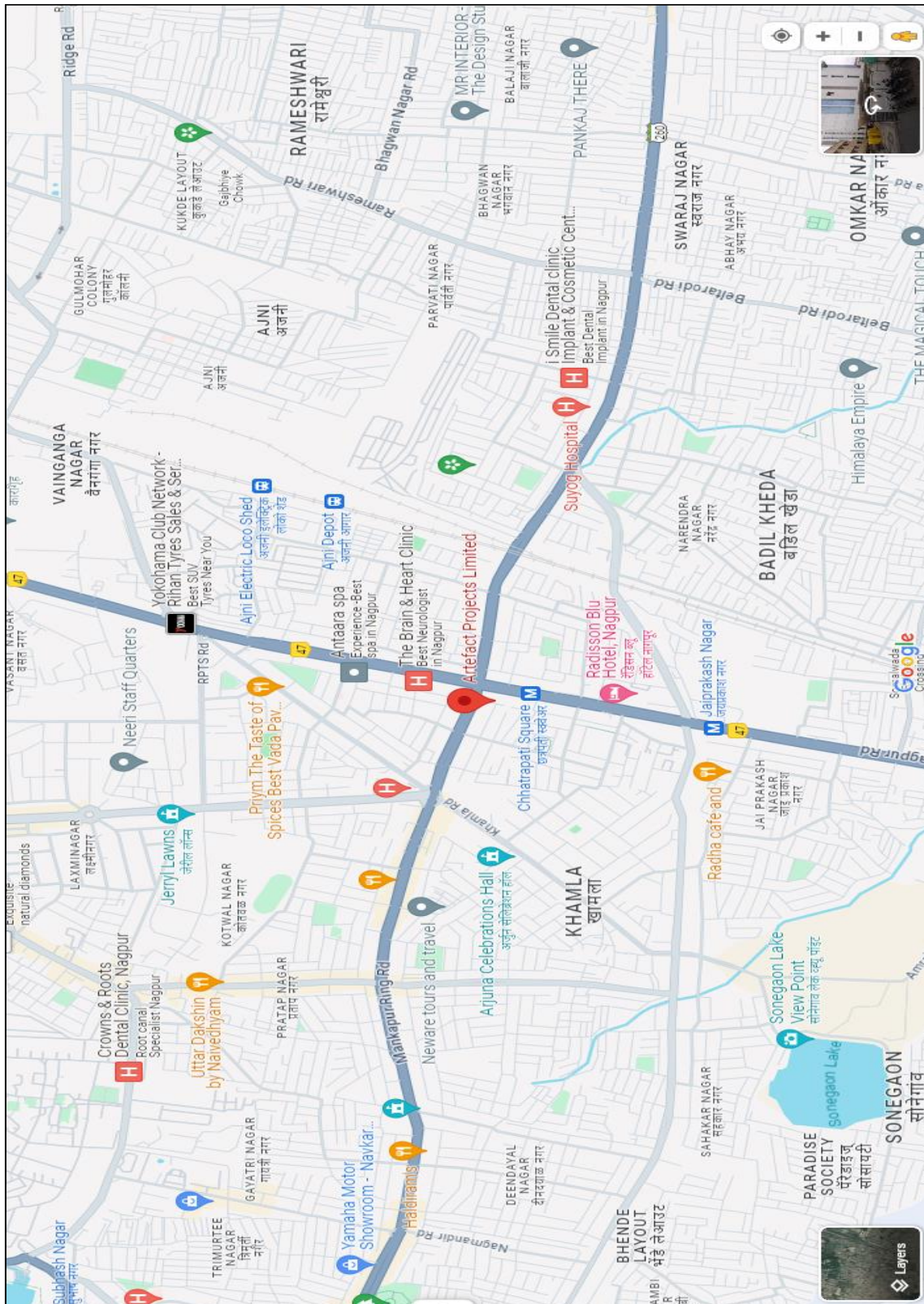

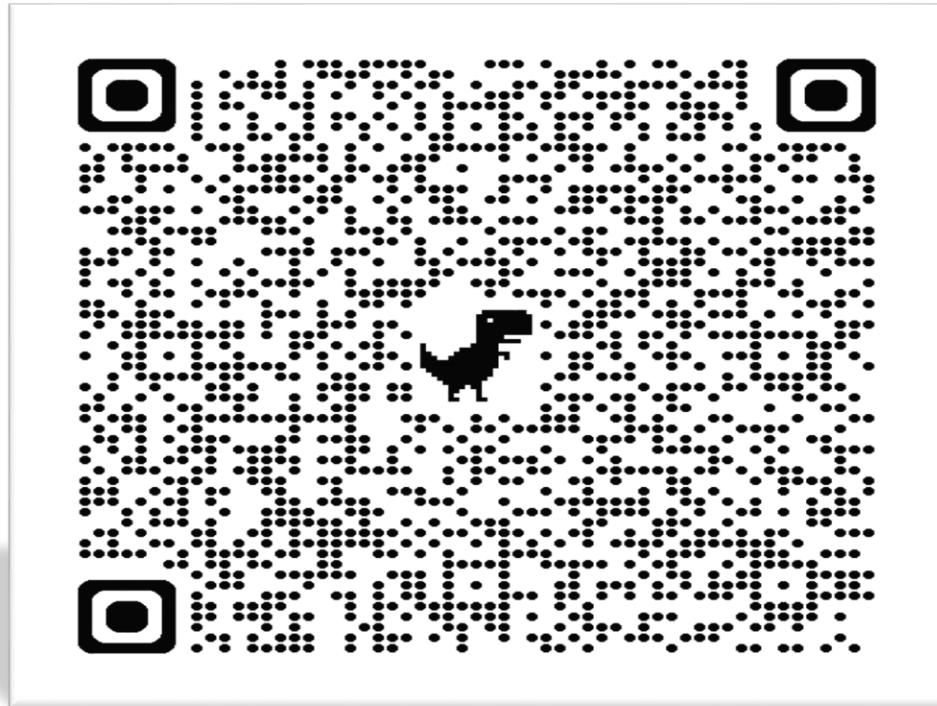

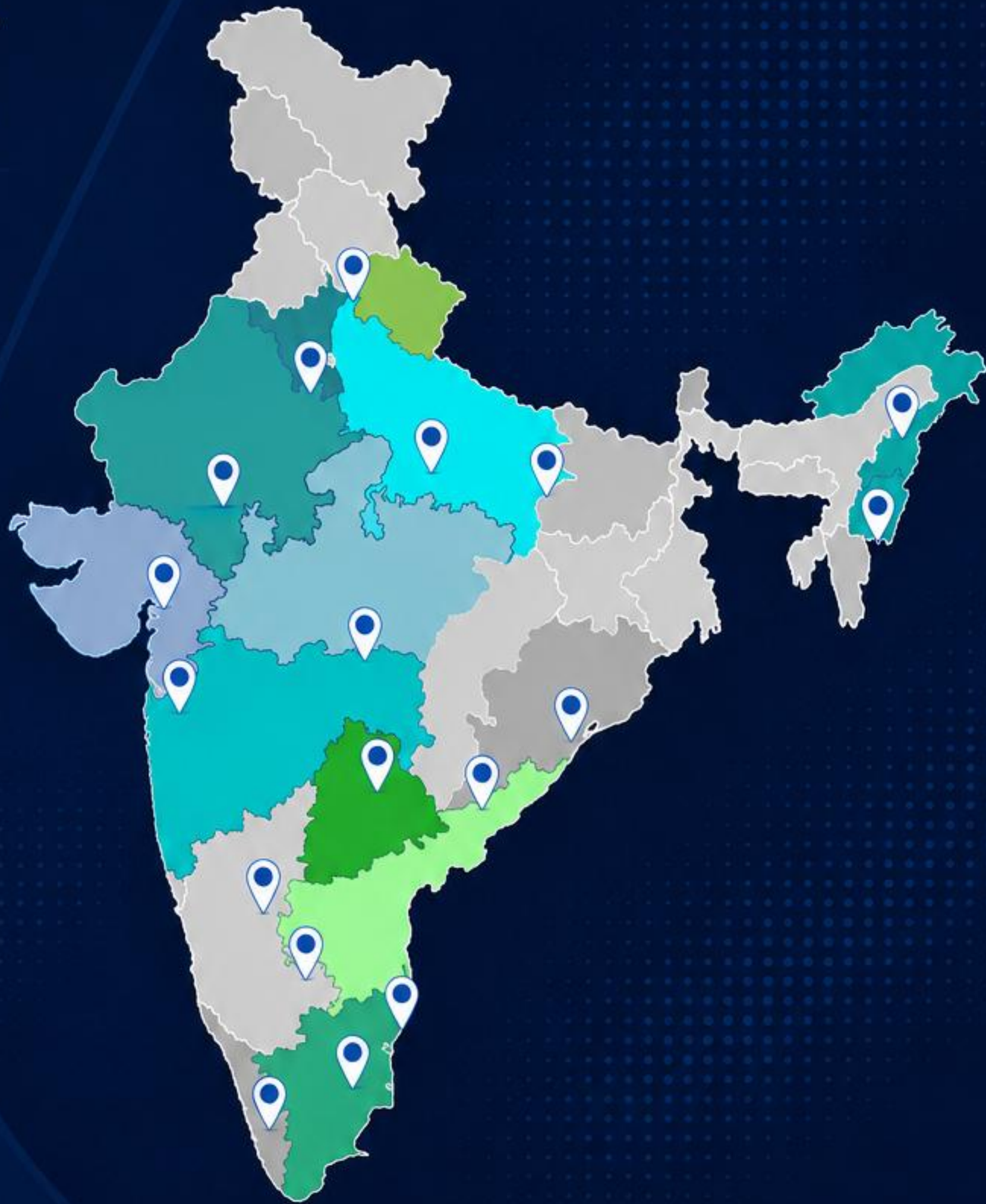
